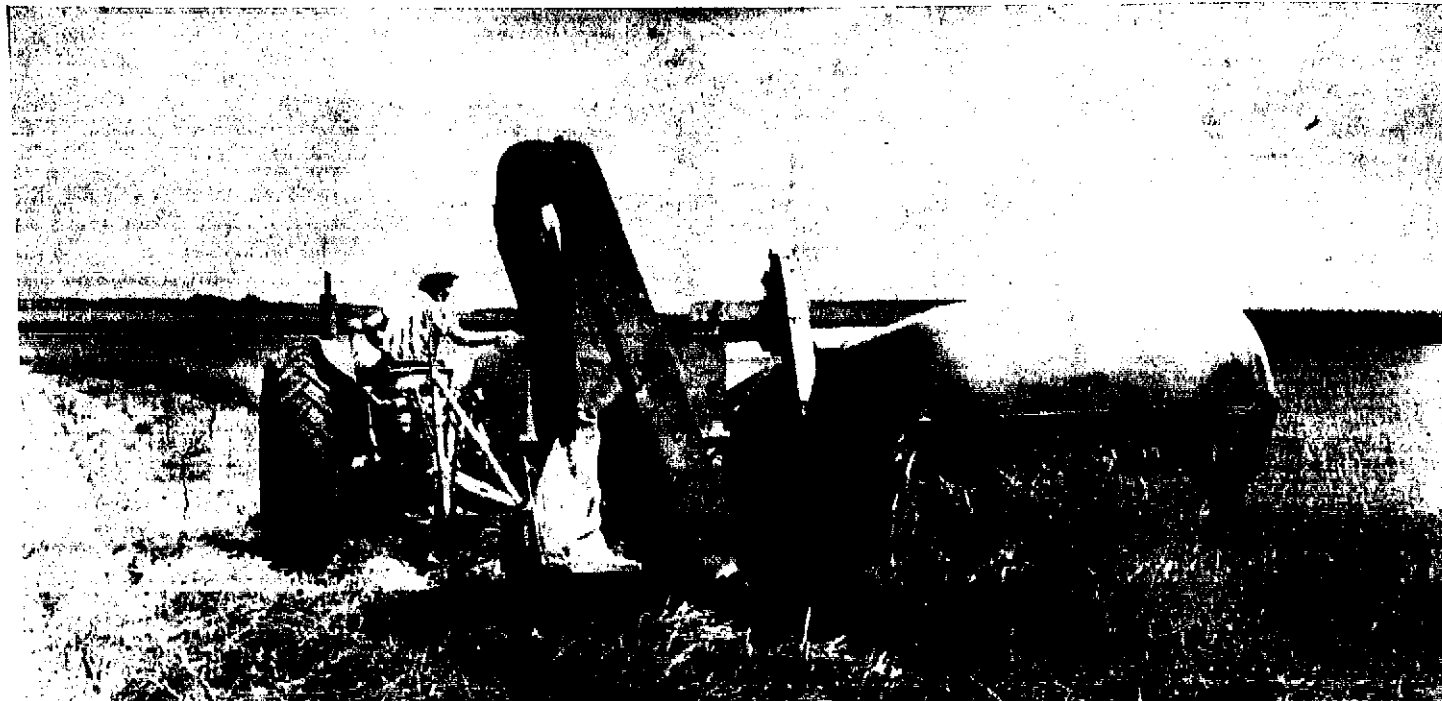


Oats harvesting underway



Many farmers in the Sumner area have completed or are in the process of completing oats combining and for some it may be the best oats crop they have ever harvested. Richard Stubenrauch, who farms two miles east of Sumner, was combining oats at his farm when this picture was taken Monday afternoon. His oats stand was excellent and the yield heavy. While there is every indication of an above average oat yield for much of this area, reports indicate this will not be true in some other parts of the state. Lack of moisture combined with too much hot weather has damaged oats in many sections. However, the Iowa Crop and

Livestock Reporting Service reports that a record yield is still expected on a bushels per acre basis with a high average of 56 bushels per acre anticipated. This would exceed by three bushels, the previous high last year and is nearly nine and a half bushels more than average. But the oat crop over the state continues a downward trend, simply because there are less acres in oats each year. The oat crop in Iowa is expected to total nearly 100,000,000 bushels, but this is two percent less than last year and 18 percent below average. Oat acreage in continuing a downward trend this year was the lowest since 1880.

He knew of one farmer friend who weighed a bushel of oats and it tipped the scale at 44 pounds. Stubenrauch said he believes his oats would equal this.

Council approves budget for year, no objectors

The Sumner City Council in their regular monthly meeting Tuesday night, August 1, voted final approval of the 1968 budget.

The budget calls for expenditures of \$204,000 of which \$104,000 will be raised through taxation. Vote on approval of the budget was four to one, with Councilman Claude Waskow, voting no.

This budget will constitute an increase of four mills in property tax for the coming year. A hearing was scheduled prior to the council's vote on the budget, but no objectors appeared.

In other business, Roger Hansen, representing the engineering firm of Bert Hansen and Associates of West Union, was on hand to discuss next Monday night's hearing on the proposed street improvement program, which will affect mainly the Fridley Addition area.

Also, Henry Hochberger of the City's Planning Commission gave a report on the Commission's plans and activities.

Two liquor license renewals were granted to Moeller's Tap and Pool and the Rite Spot.

Permission was granted the Catholic Church young people to sponsor a street dance August 9 on South Carpenter Street and a streetlight request for South Polk Street was granted.

Supervisors to ask radio equipment bids

The Bremer County Board of Supervisors have set 10 a.m. CST, August 28 as the date for letting the purchase contract for a new radio communications system for the Highway Department.

This system will consist of a Base Station with a 5000 watt generator at the County Home, a control station at the Main Shop in Waverly, another control station at the Court House in Waverly, with a 2500 watt generator and 10 mobile units in various cars and trucks.

The two generators will supply power to run the system and furnish lights for the area in the event of a power failure.

Specifications for the system have been submitted to and approved by the Federal Civil Defense Administration who will contribute 50 percent of the estimated cost of \$17,500.

The system will be used by the Highway Department in construction and maintenance of the County Secondary Road System. In the case of National or state emergency, the system will be used to control the movements of maintenance and rescue personnel and materials.
