He was first married to Mary Stone 8-7-1855 at Plattsburg, N.Y. who bore him 8 children. They came to Waterloo Ia shortly after the civil war out soon shifted to Janesville 1856 in Bremer Co and then to Waverly. The first wife and 5 daughters were deceased pevious to Mr. B. the mother died at Waverly 1-30-1961. Mr. Boveia again went to Plattsburg where he married a former acquaintance Mrs. Etta Jelley on 7-31-1911 and coming back to Waverly they lived here until the death of the father 4-3-1932 when the widow returned to the state of her childhood. Mr. B. lived continously in Bremer county from 1865 to 1932.
